3. STAFF PRESENTATION – Talula Koch, Natural Resources Manager

- T. Koch presented the following to the Park Board regarding the Natural Resources Department:
 - A video was shared that was presented to attendees of last month's Friends of Stark Parks fundraiser –
 Wild Night for Wildlife. The video featured the Joseph J. and Helen M. Sommer Wildlife Conservation
 Center and work that is being performed by staff and volunteers
 - She then presented a PowerPoint show with background and updates within the department:
 - The Department's Mission Statement: Dedicated to the conservation and management of native wildlife and their habitat through research, education and quality animal care
 - Natural Resources Management Current Staff: 2 Natural Resources Specialists, 1 Natural Resources
 Technician, and 2 Seasonals
 - Staff in the Natural Resources Department perform the following projects and tasks baseline pollinator surveys, wildlife management, invasive species management, bioswale management, native habitat installations, chestnut forest project, water quality, fish management, community events and programs
 - Baseline pollinator surveys have been completed this year at Fry Family Park in Pike
 Township, Petros Lake Park in Perry Township and Quail Hollow Park in Hartville
 - Vegetation inventory and analysis in partnership with professor Jennifer Clevenger from Walsh University at Quail Hollow Park

- Wildlife management: white-tailed deer spotlight surveys, white-tailed deer camera surveys, Canada Goose deterrent installation and Canada Goose control
- Invasive species management: removal and treatment of non-native invasive vegetation (including: Purple Loosestrife, Reed Canary grass, Garlic Mustard, Phragmigtes, Japanese Knotweed, Oriental Bittersweet, Privet, Bush Honeysuckle and Poison Hemlock)
- Bioswale installation: bioswales are landscape elements designed to concentrate or remove debris and pollution out of surface runoff water
- Native habitat installation: utilizing a new seed drill native habitat has been installed at the Zimber Ditch properties in North Canton and at Fry Family Park in Pike Township. Staff is working with marketing on interpretive signage to explain what the process to park visitors
- Chestnut forest project: staff is working at Fry Family Park to plant a grove of Chestnut trees. They will then train volunteers to collect seeds and plant the trees in other Stark Parks
- Water quality: parameters that are measured include pH, Turbidity, Oxygen,
 Temperature, and Conductivity. They also added algae sensors to monitor spikes in blooms
- Fish management: electroshocking, fish habitat creation and use sonar to locate fish structures underwater
- Trail maintenance: staff installs bat and squirrel boxes, assists the operations department
 when all hands are on deck (when there is flooding, or a significate storm), along with
 performing inspections of dams and other areas that are eroding to identify what will need
 addressed
- Wildlife Rehabilitation Current Staff: 4 Full Time Staff (1 Supervisor, 2 Rehabilitation Specialists and 1 Receptionist), 3 Part Time Staff, 6 Unpaid Interns and 7 Seasonals – plus 150+ volunteers
 - Wildlife Rehabilitation in a nutshell: providing quality animal care to native Ohio wildlife, educating the public, providing programming on native wildlife, creating opportunities for young professionals seeking employment in animal care
- The department participates in several community events and programs throughout the year including: Fishing Derbies, Woodland Encounters, Fall Fest, Ranger for a Day, Nature Series programs, Spooky Science – Beech Creek, Earth Day, various special requested programs, Bio Blitz, Eagle Scout projects, intern pop-up programs and Wild Outdoor Women's weekend (WOW)

8. NEW BUSINESS

A. RESOLUTION: #19-10-074: 2020 Tax Levy Rate and Amount

WHEREAS, the Stark County Park District Board of Commissioners in accordance with the provisions of law has previously adopted a Tax budget for the next succeeding fiscal year commencing January 1, 2020; and

WHEREAS, The Budget Commission of Stark County, Ohio has certified its action thereon to this council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by the Board of Park Commissioners, and what part thereof is without, and what part within the ten mill limitation, there be it.

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners, Stark County, Ohio that the amounts and rates, as determined by the Budget Commission in its certification, be the same are here by accepted; and

NOW, THEREFORE, BE IT RESOLVED, that there be and is hereby levied on the tax duplicate of said Park District the rate of each tax necessary to be levied within and without the ten mill limitation as follows; and

NOW, THEREFORE, BE IT FUTHER RESOLVED, by the Stark County Park District Board of Park Commissioners to accept the tax rate of 1.00 mil and the amount of Seven Million Four Thousand Four Hundred Eighty Four Dollars (\$7,004,484.00) as determined by the Budget Commission.

WHEREAS, Stark County Park District Staff removed 192 TORO sprinkler heads from the Tam O'Shanter Park grounds; and

WHEREAS, Operations Manager, Rick Summers, has determined that auctioning the sprinkler heads in November will be the most efficient way for the Stark County Park District to dispose of the sprinkler heads; and

WHEREAS, Kiko has a large auction on Saturday, November 2, 2019; and

WHEREAS, Kiko charges a commission of Twenty (20%) to Twenty Five (25%) depending on the total; and

WHEREAS, the following TORO sprinkler heads and quantities are part of Stark County Park District Inventory:

- Model 670 = 52 each
- Model 730 = 66 each

- Model 750 = 51 each
- Model 854 = 6 each
- Model DT-30 = 3 each
- Model 780 = 5 each
- Model DT-50 = 4 each
- Model 834 = 5 each

WHEREAS, Kiko needs information regarding the sprinkler heads and a signed agreement by October 9, 2019 in order to advertise.

NOW, THEREFORE, BE IT RESOLVED by the Stark County Park District Board of Park Commissioners to authorize the Park Director to execute the agreement and any other documents that may be necessary to auction the sprinkler heads on behalf of the Stark County Park District Park Board of Commissioners pending approval of said documents as to legal form and sufficiency by Attorney William Morris.

R. Fonte answered that they are older systems that can be used for people looking for parts, if they do not sell, the Park District will scrap them. R. Fonte indicated he did not know what value they have

E. RESOLUTION: #19-10-078: Termination of Mercy Gatehouse Lease

WHEREAS, the Stark County Park District is the lessee of certain real estate owned by the CSAHS/UHHS-Canton, Inc., dba Mercy Medical Center referred to as Gatehouse located at 1320 Mercy Drive, NW; Canton, Ohio; and

WHEREAS, the Stark County Park District has been approached by The Canton City Park Department to release our interest in the property to allow for Canton City to take over ownership, maintenance and operations of this facility; and

WHEREAS, the Stark County Park Director has met with the Owners, CSAHS/UHHS-Canton, Inc. dba Mercy Medical Center and they were supportive of this change.

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Board of Park Commissioners to terminate the lease agreement with Mercy Medical Center's Gatehouse within 30 days of the Stark County Park District receiving written confirmations from The City of Canton Park Department and Mercy Medical Center that they have entered into a written agreement to transfer said property to The City of Canton Park Department.

BE IT FURTHER RESOLVED, to authorize the Stark County Park Director to sign all necessary documents to accomplish the termination of said lease.

Fonte has drafted the agreement such that both parties (The City of Canton and Mercy Medical Center) will agree before the Park District terminates the lease

WHEREAS, the Park District has received grants from the Clean Ohio (CO) Conservation Fund program for the acquisition of open space in Jackson Township; and

WHEREAS, the grant funding for Phase III is in an amount not to exceed Two Million One Hundred Nine Thousand Six Hundred Ninety Five Dollars (\$2,109,695.00) for the acquisition of the Jackson Township Property; and

WHEREAS, the grant funding for Phase IV is in an amount not to exceed Two Million Two Hundred Thousand Dollars (\$2,200,000.00) for the acquisition of the Jackson Township Property; and

WHEREAS, the Stark County Park District Board of Park Commissioners approved the Tam O'Shanter Project-Phase III as part of the 2019 Project List & Budget with Resolution #19-02-018; and

WHEREAS, the Natural Resources Advisory Council (NRAC) recommends combining Grant Phases III and IV with the revised budget including a total Grant award of Four Million Three Hundred Nine Thousand Six Hundred Ninety Five Dollars (\$4,309,695.00)

WHEREAS, it is necessary to amend the 2019 Project List & Budget by an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00) for the completion of the combined Grant Phases III and IV for the acquisition of the Jackson Township Property due to a time lag in receiving NRAC Reimbursements that will occur before the end of 2019, but not prior to the closing of the final phase of the Tam O'Shanter Purchase.

NOW, THEREFORE BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners to designate Robert A. - R. Fonte spoke about the correspondence regarding HB 288. He further stated that Stark Parks has not had to use eminent domain for trail right-of-way. This bill and discussion was originated from an Ohio park director who was not open to discussing before using eminent domain in his county. Park Districts should have the same power as other entities like utilities have it makes it easier to work with them. The Park District takes the stance of trying to communicate with land owners first and if they do not agree to an easement, we wait and usually the land will become available at a later date for trail connection
- R. Fonte then updated the Park Board on the follow up conversation with Mr. Lokken from the September 4, 2019 Park Board Meeting. Staff met to review the ordinance, reached out to the Federation and Berkley Fishing Club for their feedback. Once that feedback was received, Captain Laps reached out to Mr. Lokken with five possible alternative locations
- D. Freeland asked if the clubs understand exactly what Mr. Lokken is proposing
- R. Fonte stated that Captain Laps and R. Varga of our Natural Resources department reached out to them for feedback
- D. Freeland suggested Mr. Lokken provide a presentation to the clubs to demonstrate how he would/would not interact with fishing
- R. Fonte stated if Mr. Lokken opposes the smaller lakes as options, the Park District will revisit with him
- R. Fonte reminded D. Freeland and P. Quick to contact Judge Park to renew their appointment for the Park Board
