A. RESOLUTION: #20-12-074: Exploration Gateway Capital Replacement Fund

WHEREAS, as part of the agreement for the Exploration Gateway Building (EG) between the Stark County Park District (Park) and the Stark County District Library (Library) there is a Capital Replacement Fund (Fund) in place; and

WHEREAS, the 2020 budgeted amount to be transferred to the Fund is Twenty Nine Thousand Three Hundred Seventy Dollars and Forty Four Cents (\$29,370.44).

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners to transfer Twenty Nine Thousand Three Hundred Seventy Dollars and Forty Four Cents (\$29,370.44) for the Exploration Gateway Capital Replacement Fund from 072.28.0000.82100 (Transfers Out) to 529.28.0000.72100 (Transfers In).

WHEREAS, revisions are routinely made to the Legislative Budget previously submitted to the Budget Commission; and

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners to accept the revisions and adopt the 2021 Operating Budget dated November 18, 2020 attached as Exhibit B.

BE IT FURTHER RESOLVED, to authorize the Park Director to award the contracts to the lowest and/or best bids or highest ranked qualifications submitted, provided the total cost does not exceed the original operating budget.

BE IT FURTHER RESOLVED, to authorize the Park Director to sign/execute any contracts necessary to complete the 2021 Operating Budget.

R. Fonte stated that the Park District used 2019 as a base, not 2020 to plan for 2021. We do not know when we will be able open everything up. Planning for April knowing it could be August. A lot of it depends on when vaccines are distributed. We will be ready to open facilities when it is safe

WHEREAS, the Union Negotiating Team has agreed to meet with the Park Negotiating Team with the intention of negotiating a new three year contract for January 1, 2021 through December 31, 2023; and

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners to approve extending the current contract as amended in accordance with Exhibit C as attached.
