## **RECITALS**

The Licensor is the lessee of the following described real property:

Situated in Stark County, Ohio, and in part in Sections 4 and 5 in Lawrence Township, Town 1 North, Range 10 West, of the Muskingum River Survey, and being all of the Ohio and Eric Canal as set forth in the deed from the Governor of the State of Ohio to the Board of County Commissioners of Stark County, Ohio dated September 3, 1964 and filed for record September 25, 1964 in Stark County, Ohio Deed Record Volume 3038, Page 470 and containing 25.27 acres, more or less.

Stark County Auditor's Permeant Parcel Nos. 9580074, 9580073 and 2680020. and the Licensee desires to exercise certain rights and privileges on the above-described property.

It is agreed as follows:

Licensor herby grants to Licensee the right to use the waters of the Ohio and Erie Canal and the adjacent towpath on the above-described property to operate the St. Helena III canal boat for the transportation and recreation of Licensee's patrons from St. Helena Heritage Park to Lock IV Park and back for the 2021 and 2022 summer seasons (May 1<sup>st</sup> thru October 1st).

The Licensee agrees to maintain an insurance policy with the liability of One Million Dollars (\$1,000,000.00) for injury or death to persons and Two Hundred Fifty Thousand Dollars (\$250,000.00) for damage to property, and naming the Licensor and the property owner, The Board of Commissioners of Stark County, Ohio, as additional insureds.

In consideration for this agreement, the Licensee shall pay to Licensor the sum of Ten Dollars (\$10.00).
