## 3. STAFF PRESENTATION – DANI MCGUINNESS, HUMAN RESOURCES MANAGER & PARKER SPENCER, VOLUNTEER COORDINATOR

- D. McGuinness shared the following information with the Park Board:
  - 2021 Organizational Structure: 2021, total of 98 employees (68 full time, 7 part time, 23 seasonal). In 2020 we had about 70 employees.
  - Metrics: Voluntary Turnover/Retention (permanent, year round positions):
    - 2021 July 2021 ~8.2% turnover rate (3 full time, 3 part time positions)
    - 2020 July 2020 ~11.5% turnover rate
    - o 2019 July 2019 ~6% turnover rate
    - 2018 July 2018 ~13% turnover rate
    - Average employee tenure 6.37 years
    - o 28% of staff with less than 3 years of service
    - 34% of staff with 10+ years of service
    - 9% of staff with 20+ years of service
      - B. Bryan asked if these metrics were typical?
      - D. McGuinness stated that we are most closely related to the "entertainment industry" and those numbers are at about a 12% turnover rate
      - D. Regula asked if the Park District was fully staffed at this time
      - D. McGuinness stated there are a few open positions and everything is on our website: https://starkparks.applicantpro.com/jobs/, she checks the applicants frequently to schedule interviews, etc.

    - R. Fonte stated that the Park District does not have a scoring that favors minority owned businesses when federal money is involved (i.e. Transportation) there is a set-a-side required. We used to have a preference for Stark County owned businesses, but that was eliminated by our lawyer a few years ago

Parker Spencer shared the following information with the Park Board:

  - Trailblazers and Tailblazers, FeLeap appearances, small group clean-ups (have had over 20 groups come out so far this year with us), individual/household clean-ups, citizen scientist projects (Frog Watch, Eagle Watchers, Blue Bird Box Monitoring we're building our database of information), Quail Hollow Garden Work (a work day has been scheduled each month to have volunteers come out and help maintain the historic rock garden), selective Wildlife Center volunteers (will begin taking new applications on September 15), Eagle Scout projects (currently working with a scout to install a kayak and canoe put in at Craig Pittman), mask making
  - o Zoom Trainings for Trailblazers, iNaturalist and onboarding
- 2021 Volunteer Metrics:
  - o 197 active volunteers
  - o 329 total volunteers
  - o 60% were active this year so far
  - o 33 new volunteers in 2021
  - Total volunteer hours 6,929.9 (this includes groups and short-term volunteers volunteering under a waiver)

- D. Regula asked if any of the revenue will go to the park from the sale of the lottery?
- J. Laps stated that the \$15 fee to enter the lottery will generate some revenue. We expect anywhere from 150 to 200 entrants. The Ohio Department of Natural Resources (ODNR) hunting/fishing license proceeds go towards stocking the lakes
- D. Regula asked if we have a hold harmless waiver form?
- J. Laps stated that landowners are not liable in public hunting zones
- R. Dublikar stated the recreational user statute protects landowners

**WHEREAS,** the Tuscarawas River was officially designated in August, 2020 as a Water Trail by the Ohio Department of Natural Resources; and

*WHERAS,* the Village of Navarre is the owner of 14.0 acres of land located in the Southeast Quarter of Section 5, Bethlehem Township, Stark County, Ohio, and 18.13 acres of land located in the Village of Navarre, Stark County, Ohio, being Stark County Auditor's Permanent Parcel Nos. 1080050 and 10006545, and claims title through instruments recorded at Volume 973, Page 307 of the Stark County Official Records and Volume 3149, Page 420 of the Stark County Deed Records; and

**WHEREAS,** the Stark County Park District and Village of Navarre have declared their intent to establish a permanent easement for the location and maintenance of a Water Trailhead along the Tuscarawas River attached as Exhibit D; and

**WHEREAS,** the Stark County Park District would be responsible for the maintenance and repair of the easement area and any appurtenances to support the water trailhead including a drop-off drive, small watercraft launch ramp, and signage.

**NOW THEREFORE BE IT RESOLVED,** by the Stark County Park District Board of Park Commissioners that the Park Director is authorized to execute an easement agreement with the Village of Navarre for the purposes of developing a Water Trailhead attached as Exhibit D; and

**BE IT FURTHER RESOLVED,** that Robert A. Fonte, Park Director, is authorized to sign/execute the necessary instruments to effectuate the project as outlined above.
