FACILITY RENTAL POLICY

RESERVATIONS

Reservations can be made in person at the park office at 5712 12th St. NW, Canton or by visiting www.StarkParks.com. Reservations must be paid at the time of the request to be considered valid. Reservations for the next season can be made one year in advance with renewal reservations being given right of refusal for 10 days following the current year's reservation.

The reservation form is your confirmation and you should bring it with you to avoid confusion.

SCHEDULE OF RESERVATIONS

Rental periods for the Clubhouse and Boat Shelter are broken into two (2) time periods per day (10 am to 3:30 pm and 5:30 pm to 11 pm). **Effective January 8, 2004, two (2) hours will be scheduled between reservations to allow the staff to clean the facility and set-up for the next reservation.** Reservations can be made for combined morning and evening time periods, in which case the daily rate applies.

TIME OF ARRIVAL

Failure to arrive at your reservation time may result in a delay of entrance to the facility. Please remember to mark your arrival time on your reservation card. If you arrive at a time other than what you have listed, you will have to contact a Park Ranger at (330) 353-2377. Keep in mind, the Park Rangers are patrolling all the Stark County Parks and may not be available immediately. Please note that those scheduled to arrive at 10 am or 5:30 pm will be allowed in the facility no earlier than 15 minutes prior to their scheduled time.

PARK RULES AND REGULATIONS

The following rules and regulations have been adopted by the Stark County Park Board or mandated by existing laws governing Park Land:

Smoking is not permitted in any park building.

Alcoholic beverages are not permitted on park property, except as specifically provided detail exceptions.

Live bands and disc jockeys are prohibited. The volume of recorded or amplified music must be kept low so as not to be heard beyond 100 feet of the source, except as specifically provided detail exceptions.

Themed Inflatables (such as Bounce Houses and slides) are prohibited.

Reservations must be cancelled thirty (30) days in advance. Failure to cancel reservations as stated will result in forfeiture of the reservation fee.

Decorations – Do not hang using staples, tacks or tape. Use of confetti and rice are not permitted due to limited cleanup time allowed between reservations and environmental considerations.

Portable cookers such as gas grills, turkey fryers, etc. are prohibited.

Open flames are not permitted. According to the Fire Code candles must be in an enclosed globe on a table.

Any exceptions to these rules and regulations may be approved on a case-by-case basis. Any violations of park regulations may result in refusal of any future reservations.

SAVE/HOLD HARMLESS CLAUSE

"The LESSEE agrees that the STARK COUNTY PARK DISTRICT shall not be liable for claims for injury to persons or property from any cause relating to the occupancy/use of the premises by LESSEE. The LESSEE shall indemnify and hold harmless the STARK COUNTY PARK DISTRICT from all liability, loss, or damage claims or obligations resulting from any injuries or losses due to the occupancy/use of the premises by the LESSEE from any cause whatsoever".
