1. CALL TO ORDER — The regular meeting of the Stark County Park Commission was called to order by Denise Freeland at 2:03 p.m.

B. Adoption of Agenda

B. Bryan MOVED to adopt the agenda, which was SECONDED by D. Regula

2. PUBLIC COMMENT

- D. Pugh thanked the Park Board for agreeing to talk with trustees about potential Park District land purchases in their respective areas.
- J. Staley stated that he had been asked about the plans at Tam O'Shanter Park with the land swap. He asked about the intended purpose and commercial use on the land.
- R. Fonte answered that the covenants on the land are restricted and the intent is to swap five to eight acres from Tam O'Shanter Park with similarly valued land. The proposed commercial use on the land is in response to the public meetings that were held during the Master Planning for the park. The Park District is currently looking to contract out the former clubhouse to a vendor to operate as a restaurant and bar. The Park District is also exploring adding a high ropes course and zip lines to serve the active recreation needs identified in the Master Plan. These revenue opportunities will help to continue to balance the budget and continue Park District operations without a tax increase.
- J. Staley referred to the Landscape Masterplan published for Tam O'Shanter Park and asked about those plans and the Natural Resources Advisory Council (NRAC) restrictions.
- R. Fonte stated that the Park District had purchased the land and the Park Masterplan was developed based on public meetings and partnering with Jackson Township and the commercial development. From that feedback, the Park Board is trying to react to the publics input. The Park District is also planning to partner with Visit Canton on a financial analysis to justify the investment.
- J. Staley stated some people may have a concern that the venue would be in competition with others in the area for weddings and other events.
- R. Fonte stated that the Park District has a similar building at Sippo Lake, the Exploration Gateway, where events and weddings are held. The building is shared with the Perry Sippo Branch of the Stark County District Library. In order for

the Park District to allow a private vendor to operate the restaurant at Tam O'Shanter we would need to have the covenants changed.

- E. Pugh asked if the Park District was applying for any Natural Resources Advisory Council (NRAC) grants this year.
- R. Fonte answered, yes, they are for site improvements in current parks (Fry Family Park and Walborn Reservoir (Bingham Property).
- E. Pugh asked if the townships those parks are in were contacted.
- R. Fonte stated no, they are for restoration (planting prairie grasses, trees, etc.) and the Park District is not required to notify the Township of site improvements. [Correction: the Townships were contacted, although not required by the grantor]
- E. Pugh asked about Tam O'Shanter Park and changing the land use. How can the Park District change the land use without an elected official's approval?
- R. Fonte stated that he had talked with Jackson Township. Once they approve the plan they will approve the NRAC request for the change of use. The Park District would also go over the plans in a public meeting.
- E. Pugh stated he is trying to see what can be changed in the future, as he has concerns with the property that is next to his as it was acquired using the same grant monies.
- E. Pugh asked about plans to expand the clubhouse at Tam O'Shanter.
- R. Fonte stated this is the first time the Park District has ever explored doing this. The liquor license is in 'sleep mode' and the Park District paid for the license. Legally the license must be transferred to a vendor in order to operate.
- E. Pugh asked if there was any way to have a recording of the Park Board meetings for those who cannot attend in person.
- D. Freeland asked if E. Pugh was looking for video, audio or both.
- E. Pugh stated audio was fine and said it seemed pretty commonplace these days to have an audio recording of public meetings. [Note: the Board is considering Dr. Pugh's request in context of pending legislation that will affect the future use of technology in conducting public meetings.
- D. Freeland presented R. Fonte with a Certificate of Appreciation for 25 Years of Dedicated Service to the Stark County Park District.

A. RESOLUTION: #21-02-015: 2021 Project List & Budget

WHEREAS, all 2021 proposed county-wide projects and as well as individual department projects, have been reviewed and prioritized in Exhibit A; and

WHEREAS, the Park Director has proposed that the projects listed under "Category 1" be approved for inclusion in the 2021 Budget.

B. Bryan MOVED to adopt this resolution, which was SECONDED by R. Dublikar

DISCUSSION:

- R. Fonte presented the Park Board of Commissioners with a PowerPoint presentation detailing the 2021 Project List & Budget:
 - The first slide included a photo of a bench along the Mindfulness Walk at Petros Lake Park in Perry Township. The Park District won the <u>Governor's Award</u> in 2019 and this has been a great resource through the pandemic.
 - o B. Bryan asked what year the lake at Petros Lake Park was dug?

- R. Fonte answered that it was constructed in 1985, the same year as the TimkenSteel
 plant on Faircrest was built. It was created to catch the water so the steel mill was not
 flooded.
- The Park District spreads the projects throughout the county:
- East
 - Walborn Reservoir: convert the parking lot lighting to LED
 - Quail Hollow Park: last year partnered with the Cleveland Area Mountain Bike Association (CAMBA) to build a bridge on the mountain bike trail, this year we'll do some armoring for the entrance and exit of the bridge. We'll work to fix the heat source in the Quails Nest Gift Shop. We will make some repairs to protect the Manor House from water intrusion and install pathway lights from the parking lot to the Manor House/Nature Center.
 - Fichtner Park: was used temporarily as the Wildlife Center while the new Center was being constructed at Sippo Lake. This year we'll tear down the house and barns on the property.
 - D. Freeland asked if the Park District contacts Habitat for Humanity prior to tearing the buildings down.
 - R. Fonte answered that the Park District recycles and repurposes as much as possible.

West:

- Sippo Lake Park Wildlife Conservation Center: the lights in the parking lot leaked and failed just after their warranty expired, so they now need replaced. We will plan to use the lights from Fry (being replaced for "Dark Sky" compliance) at the Wildlife Conservation Center. The Park District also plans to continue the exhibit hall construction inside the building.
- Congressman Ralph Regula Towpath Trail: Nimisila Creek Preserve restoration and planting grant funded projects. We are also working with Summit Metro Parks to repair the Canal Feeder Diversion Dam. Also, adding various locations for access to the Tuscarawas River Water Trail in partnership with Muskingum Watershed Conservancy District and Friends of Stark Parks. Will also work to eliminate the at-grade crossing at Riverland Road in the southern portion of the trail.
- Sippo Valley Trail: repairing one bridge this year and applying for a grant to repair another in 2022.
- Tam O'Shanter Park: Working on the design of the parking lot and driveway and Adventure Park for future revenue generation as well as a potential lease on the clubhouse. Continuing with site restoration and prairie grass plantings. Most of the investment is through grants and in-kind with our staff labor.
- Jackson Connector Trail: Tunnel Under Fulton Road in partnership with Jackson Township Trustees and Jackson Local Board of Education as a portion of the Jackson Connector Trail between North Park and the Stark County District Library Jackson Branch, Jackson High School and Jackson Bog. Stark Parks is applying for Clean Ohio Trail Funds, in the amount of \$500,000 to offset the partner's share of the construction costs (\$579,793.00). If the grant is successful this would reduce Stark Parks' share to \$26,597.57. Construction of the tunnel is scheduled for 2022.
- Devonshire Park: The Park District accepted properties donations near Devonshire Park that can serve as a long-term connection to Tam O'Shanter Park.

• In the Middle:

The Zimber Ditch area in North Canton has experienced increased flooding over the years due to development upstream and the expansion of impervious surfaces such as parking lots and the roads along the I-77 Corridor. Stark Parks, the Stark County Commissioners, the City of North Canton, and the Muskingum Watershed Conservancy District partnered to apply for the Emergency Management dollars to fund flooding mitigation projects. Stark Parks has served as the project manager and grant applicant in this effort since 2014.

- 19 houses have been demolished
- 3 homeowners have declined
- 4 houses are to be acquired/demolished as part of Increment 6 (PDM Grant)
- 10 houses are to be acquired/demolished as part of Increment 7 (HMGP Grant)
- 33 TOTAL houses projected to be demolished if they all accept
- Middle Branch Trail:
 - Faith Bible Church: The installation of a Wetland and Trail that will connect Lexington Farms to Firestone Road and eventually to the Middle Branch Trail and then to the Saratoga Hills Development.
 - We're also working on the connection between the Hoover and Middle Branch Trails at the Fountains at Edgewood. This will give this neighborhood direct access to the Hoover Trail and Washington Square area.
- o Fry Family Park: We'll work on the design for the fishing dock at the pond, install hand dryers in the shelter restrooms and the exhibit design and construction in the Visitor Center. We're also continuing improvements for Dark Sky compliance by upgrading the parking lot lighting (the whole park will be a Certified Dark Park). We'll also work on landscaping around the Visitor Center.
 - D. Regula inquired about the installation of hand dryers at Fry Family Park. D. Regula explained that due to COVID-19, the Akron Canton Airport unhooked and covered the dryers in the restrooms. He stated the Park District may want to explore other alternatives.
 - R. Fonte stated he would have the Operations Department look into the alternatives
- Magnolia Flouring Mills: We're continuing the building restoration and exhibit design with a state capital grant.
- Minerva Connector Trail: We're working on the Sandy Creek Bridge design to connect the Minerva Connector Trail to the Nickel Plate Trail. Construction is slated for 2025.

• Park-wide Projects:

- We'll be working on resurfacing up to 10 miles of trail (stone, chip and seal and/or asphalt of high maintenance areas). The Operations Department has been able to perform the paving using limestone much more efficiently with the new paver.
- We're continuing to work towards cutting trail maintenance and patrol costs. These are currently at about \$5,300 per mile in combined costs.
 - D. Regula asked if there was any other trail surface that can be used that is more cost effective than limestone.
 - R. Fonte stated that limestone is Americans with Disabilities Act (ADA) compliant and does not get super saturated and turn to mud like some other surfaces. R. Fonte explained further that the Park District has the equipment to pave trails with limestone.
 - B. Wells explained that the Park District does use some slag in certain places.
 - R. Fonte stated typically the Park District will pave with limestone right away over the slag to maintain ADA compliance.
 - D. Regula asked if the townships that the Park District's trails run through have taken advantage of any grants for patrolling with all-terrain vehicles (ATV's).
 - R. Fonte stated that the grant program for ATV's is no longer available.
 - D. Freeland asked about the Magnolia Flouring Mills funding.
 - R. Fonte stated that the Park District was awarded \$50,000 from the State Capital Grant. The county did well as a whole, \$500,000 was awarded to

Jackson Township for their soccer complex at Tam O'Shanter and Kent State University at Stark and Stark State received \$50,000 for the trail through the campus.

WHEREAS, grants have been awarded from Federal Emergency Management Agency (FEMA) and Ohio Emergency Management Agency (OEMA) in a total amount of Two Million Eight Hundred Ninety One Thousand One Hundred Sixty Five Dollars (\$2,866,540.00):

- Pre-Disaster Mitigation Fund (PDM) in the amount of Nine Hundred Seventy Six Thousand Six Hundred Sixty Five Dollars (\$976,665.00)
- Hazard Mitigation Grant Program (HMGP) FEMA-DR-4360.20-R-OH in the amount of One Million Eight Hundred Eighty Nine Thousand Eight Hundred Seventy Five Dollars (\$1,889,875.00); and

WHEREAS, the remaining PDM budget for 2021 is Five Hundred Forty Six Thousand Five Hundred Eighty Seven Dollars and Thirty Nine Cents (\$546,587.39); and

WHEREAS, the HMGP budget for 2021 is One Million Eight Hundred Eighty Nine Thousand Eight Hundred Seventy Five Dollars (\$1,889,875.00); and

WHEREAS, it is necessary to amend, certify and appropriate the Fund 696 in the 2021 Budget by an amount not to exceed Two Million Four Hundred Thirty Six Thousand Four Hundred Sixty Two Dollars and Thirty Nine Cents (\$2,436,462.39) for the completion of PDM and HMGP Grant Program.

E. RESOLUTION: #21-02-019: Clean Ohio Trail Fund Application: Jackson Connector Trail-Tunnel Under Fulton Road

WHEREAS, the Jackson Connector Trail is a trail identified on the Stark County Trail and Greenway Master Plan; and

WHEREAS, the Stark County Park District Board of Park Commissioners authorized the Park Director to apply for Transportation Alternatives (TA) Funds for the construction of a tunnel under Fulton Road in Jackson Township with Resolution #18-08-045 in partnership with the Jackson Local Board of Education and the Jackson Township Trustees; and

WHEREAS, the current construction estimate for the Tunnel Under Fulton Road is One Million Two Hundred Fifty Eight Thousand Nine Hundred Fifty Nine Dollars (\$1,258,959.00) of which Five Hundred Seventy Nine Thousand Seven Hundred Ninety Three Dollars (\$579,793.00) is the responsibility of the partners; and

WHEREAS, Stark County Park District and its partners desire additional financial assistance under the Clean Ohio Trail Fund (COTF) Grant Program to offset the construction costs of the Tunnel Under Fulton Road Project; and

WHEREAS, the reimbursement rate for the COTF grant is Seventy-Five Percent (75%) of the project, requiring matching funds of a minimum of Twenty-Five (25%); and

WHEREAS, the total grant funding request including match is equal to Six Hundred Sixty Six Thousand Six Hundred and Sixty Seven Dollars (\$666,667.00); and

WHEREAS, the Park District is seeking Five Hundred Thousand Dollars (\$500,000.00) in COTF grant funds from the Ohio Department of Natural Resources;

WHEREAS, the grant requires a Twenty Five Percent (25%) match requirement in the amount of One Hundred Sixty Six Thousand Six Hundred Sixty Six Dollars (\$166,667.00); and

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners to authorize the Park Director to provide all information and documentation required to become eligible for possible funding assistance, and agrees to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms and conditions of the Clean Ohio Trail Fund (COTF) Grant Program.

F. RESOLUTION: #21-02-020: Recreational Trail Program Application: Sippo Valley Trail Bridge Replacement

WHEREAS, the Stark County Park District (SCPD) desires financial assistance under the Recreational Trails Program (RTP), an assistance program of the U.S. Department of Transportation's Federal Highway Administration (FHWA) to replace a bridge along the Sippo Valley Trail; and

WHEREAS, Sippo Valley Trail bridge, known as Bridge Number Eight (#8), has been identified as being in serious condition according to the 2020 Stark Parks Bridge Inspection Report performed by Hammontree & Associates LTD; and

WHEREAS, the construction cost for Bridge Number Eight (#8) is estimated to be Two Hundred Eighty Thousand Dollars (\$280,000.00); and

WHEREAS, the reimbursement rate for the RTP grant is Eighty Percent (80%) requiring matching funds of a minimum of Twenty Percent (20%); and

WHEREAS, the total grant funding request including match amounts to One Hundred Eighty Seven Thousand Five Hundred Dollars (\$187,500.00); and

WHEREAS, SCPD is seeking the maximum funding amount of One Hundred and Fifty Thousand Dollars (\$150,000.00) from RTP; and

WHEREAS, the remaining balance paid by SCPD, will be approximately One Hundred and Thirty Thousand Dollars (\$130,000.00) exceeding the required match due from SCPD of Thirty Seven Thousand Five Hundred Dollars (\$37,500.00).

NOW, THEREFORE, BE IT RESOLVED, by the Stark County Park District Board of Park Commissioners to authorize the Park Director to provide all information and documentation required to become eligible for possible funding assistance, and agrees to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms and conditions of the Recreational Trail Program (RTP).

WHEREAS, the Stark County Park District disagrees with the decision of the BWC and since it was determined by the Stark County Park District to be necessary to send the employee for medical treatment.
